

Bridge Street Theatre Statement of Privacy

Bridge Street Theatre is committed to protecting your privacy. This Statement of Privacy applies to Bridge Street Theatre Web site and governs data collection and usage at all Bridge Street Theatre sites and services; it does not apply to other online or offline sites, products or services. Please read the Bridge Street Theatre Statement of Privacy. Bridge Street Theatre is a general audience web site, intended for users of all ages. Personal information of all users is collected, used and disclosed as described in this Statement of Privacy.

Collection of your Personal Information

As an E-commerce Web site, Bridge Street Theatre collects personal information, such as your e-mail address, name, home or work address or telephone number. Information collected by Bridge Street Theatre is used solely for the purpose of billing and shipping your online purchases. Bridge Street Theatre does not collect any information about your computer hardware and software.

Bridge Street Theatre encourages you to review the privacy statements of Web sites you choose to link to from Bridge Street Theatre so that you can understand how those Web sites collect, use and share your information. We are not responsible for the privacy statements or other content on Web sites outside of the Bridge Street Theatre Web site.

Use of your Personal Information

Bridge Street Theatre and its operational service partners may collect and use your personal information to process orders and deliver the products requested. It is possible that Bridge Street Theatre may also use personal information to inform you of other products or services available from Bridge Street Theatre and its affiliates. Bridge Street Theatre may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

Bridge Street Theatre does not sell, rent or lease its customer lists to third parties. Bridge Street Theatre may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your personal information (e-mail, name, address, telephone number) is not transferred to the third party.

We occasionally hire other companies to provide limited services on our behalf, such as handling the processing and delivery of mailings, providing customer support, processing transactions, or performing statistical analysis of our services. We will only provide those companies the personal information they need to deliver the service. They are required to maintain the confidentiality of your information and are prohibited from using that information for any other purpose.

Bridge Street Theatre does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

Bridge Street Theatre may access and/or disclose your personal information if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Bridge Street Theatre or the site; (b) protect and defend the rights or property of Bridge Street Theatre, including its Web site; or (c) act under

exigent circumstances to protect the personal safety of users of Bridge Street Theatre or the public.

Personal information collected on this site may be stored and processed in the United States or any other country in which Bridge Street Theatre or its affiliates, subsidiaries or agents maintain facilities, and by using this site, you consent to any such transfer of information outside of your country. Bridge Street Theatre abides by the safe harbor framework as set forth by the U.S. Department of Commerce regarding the collection, use, and retention of data from the European Union.

We use a variety of security technologies and procedures to help protect your personal information from unauthorized access, use, or disclosure. For example, we store the personal information you provide on computer systems with limited access that are located in controlled facilities. When we transmit highly confidential information (such as a credit card number) over the Internet, we use a secure payment gateway so your information is protected.

Bridge Street Theatre will occasionally update this Statement of Privacy to reflect company and customer feedback. If there are material changes to this Statement or in how Bridge Street Theatre will use your personal information, Bridge Street Theatre will prominently post such changes prior to implementing the change.
